SOLIDWORKS Desktop Release 2025

LICENSED PROGRAMS

This OST (Offering Specific Terms) and the terms incorporated herein by reference (including terms referenced on a website) are an integral part of the license and online services agreement between 3DS and Customer (“Agreement”), which refers to this OST. In the event of a discrepancy, inconsistency or contradiction between this OST and the other terms of the Agreement, the provisions of this OST shall prevail, but only with respect to the Licensed Programs to which this OST applies. Customer acknowledges that it has full knowledge of all the terms of this OST and those incorporated herein by reference.

1. PRICING STRUCTURES

Licenses and Support Services for the Licensed Programs to which this OST applies are granted according to the pricing structures mentioned in the related Transaction Document. Standard pricing structures are defined in the section “DEFINITIONS” of this OST, even though those pricing structures may not be applicable to the 3DS Offerings to which this OST applies. Other pricing structures may be made available on a case-by-case basis.

2. LICENSING SCHEMES AND GEOGRAPHIC SCOPE

2.1 GENERAL RULES

Licenses for the Licensed Programs to which this OST applies may be granted according to one of the following licensing schemes (specifying the authorized use), as specified in the Product Portfolio if available, and as determined in the applicable Transaction Document:

- Single User (Standalone)
- SolidNetWork (SNL)

Licenses for the Licensed Programs to which this OST applies are granted for use on Machines by the Users (and Extended Enterprise Users, as applicable) only in the country for which the 3DS Offerings are ordered. However, (i) Users, whose usual workplace is located in the same country as the country where such use of the Licensed Programs has been authorized, may use the Licensed Programs in any other country (subject inter alia to the export and re-export laws and regulations provisions of the Agreement) for purposes of a business trip of a maximum of thirty (30) consecutive days and (ii) 3DS may authorize, on a case-by-case basis, the use of certain Licensed Programs by the Users (and Extended Enterprise Users and/or Affiliates Users, as applicable) on a Remote Access mode.

It is agreed that, notwithstanding anything to the contrary provided in the Documentation, software components packaged and delivered by 3DS as part of a given 3DS Offering:

- shall solely be used together and as part of such 3DS Offering and
- shall not be used standalone and/or for other purposes than the ones for which such 3DS Offering has been marketed and granted to Customer by 3DS.

If a patent invention is implemented in the 3DS Offering for which a right to use or access is granted pursuant to the Agreement, 3DS hereby grants Customer a non-exclusive license on the applicable patent limited to the use of such 3DS Offering.

The Customer must reactivate each license of the 3DS Offering, (i) one (1) year after the initial activation of the license, (ii) one (1) year after each subsequent reactivation of the license and (iii) at all one (1) year intervals thereafter. In the event the activation of any of these licenses expires and is not reactivated, the activation and the use of the 3DS Offering will cease and will not be operational until reactivation. This does not affect the perpetual license right to use granted under the PLC pricing structure.

2.2 SPECIFIC PROVISIONS FOR CERTAIN 3DS OFFERINGS

2.2.1 SOLIDWORKS Single User (Standalone) 3DS Offerings

As part of the 3DS Offering, the Customer is granted the right to use one (1) SolidNetWork License of *with SOLIDWORKS PDM Standard CAD Editor*, if applicable as shown below in Table 1. For other items listed in Table 1 and if current on ALC for such 3DS Offerings, or if such 3DS Offerings are under YLC or QLC, the Customer is granted the right to use the applicable Licensed Programs of the specific 3DS Offering.

With the exception of ‘Add-on’ licenses that shall be installed on the same machine as referenced in the 3DS Offering name, use of each 3DS Offering in Single User (Standalone) mode is authorized for Machines up to the number of Licensed Programs included in the 3DS Offering for which it has been ordered, unless otherwise specified.

In the case where the Machine is changed, the Customer may contact 3DS to update the machine information for activation purpose.

2.2.2 SolidNetWork (SNL) 3DS Offerings

As part of the 3DS Offering, the Customer is granted the right to use one (1) SolidNetWork License of *with SOLIDWORKS PDM Standard CAD Editor*, if applicable as shown below in Table 3. For other items listed in Table 3 and if current on ALC for such 3DS Offerings, or if such 3DS Offerings are under YLC or QLC, the Customer is granted the right to use the applicable Licensed Programs of the specific 3DS Offering.

3DS Offerings under SolidNetWork (SNL) licensing scheme must be installed on a network server that:

- will permit the number of licenses that Customer has acquired to be used within the country for which licenses have been granted, by a maximum number of simultaneous Users and Affiliate's Users (and Extended Enterprise Users, as applicable).
- may include Licensed Programs to be used in different countries as long as each Licensed Program is licensed by either the Customer or Customer's Affiliate for the country in which it is used, and may be used only by authorized Users and/or authorized Affiliate's Users, as appropriate. Such countries shall be within the same territory as the network server. For this purpose, 3DS considers there to be three (3) territories: Americas, Europe/Middle-East/Africa, and the rest of Asia/Australia. Such restriction does not apply to any 3DS Offering authorized as Extended Enterprise User and Remote Access if so specified in the Product Portfolio, including but not limited to *SOLIDWORKS Manage Professional*, *SOLIDWORKS PDM Standard* and *SOLIDWORKS PDM Professional* 3DS Offerings.
- is subject to a one-time fee payment: such fee may be applied upon the initiation of any network server.

The original licensors of said open source software components provide them on an “as is” basis and without any liability whatsoever to Customer.

4.2 ADDITIONAL THIRD PARTY TERMS

5.1 GENERAL DEFINITIONS

Configuration or **Package** means a standard set of 3DS Offerings which are bundled together. The 3DS Offerings composing such Configuration or Package shall only be operated together.

Development Tool Kit means a 3DS Offering specifically designed for application or content development. A Development Tool Kit is either identified (i) with "CAA" or "ENOVIA Studio" or "Toolkit" or "Development Toolkit" in the 3DS Offering name, or (ii) in the Transaction Document and/or the Product Portfolio.
